

# PRIVACY POLICY RPS LEAGUE

Effective: December 18, 2021

The domain <https://play.rpsleague.io/> and all its contents are owned by RPS LEAGUE., Hereinafter RPS. Your visit to the Website and the use of our Game (hereinafter the "services") is subject to this Policy on the Processing of Personal Data. This privacy policy describes how RPS collects, uses and discloses information about you when using our services, and the choices you have regarding that information.

We use your data to provide and improve the Services. By using the Services, you agree to the collection and use of information in accordance with this policy. Likewise, when accessing and / or using the Site and / or the Game, it is assumed that you are fully aware, understand and accept that this Privacy Policy will be updated in accordance with data protection legislation, and will be applied immediately without informing you, and without your consent, as long as you continue to use the Services. Therefore, we recommend that you carefully read this Privacy Policy as well as the Terms of use and the Legal Notice of responsibility.

## I. COLLECTION AND USE OF INFORMATION

To the extent that the Information is associated with an identified or identifiable natural person and is protected as personal data in accordance with applicable data protection law, we will refer to it in this Privacy Policy as "Personal Data". RPS will only collect that information that is necessary for the provision of the Services, being able to receive this data in several ways:

Types of data collected:

1. Information that you provide to us directly - including, but not limited to:

Your account information, including your email address, username, real name, country, date of birth, phone number, and uniquely identifying Crypto wallet information;

Information you provide in response to surveys on our Services;

Information you provide when you request our help, such as your name, phone number, and records (including call recordings) of problems you experience.

2. Information You Provide When You Play Online

When you participate in social features of the Site and / or the Game, such as chat, any audio, visual and / or electronic information that you reveal may be read, copied, collected or used by other players, and may become publicly available. When you participate in the Game, your in-game profile information, gameplay and statistics

are visible. In competitive game modes, we may record your game at our sole discretion.

### 3. Other information we collect when you use our services

We may collect other information automatically when you use our Services, including but not limited to:

IP address;

Information about your device, hardware and software, such as your hardware identifiers, mobile device identifiers (such as Apple Advertising Identifier [IDFA] or Android Advertising ID [AAID]), platform type, configuration and the components, our software and updates that you have installed and the presence of necessary add-ons;

Approximate geolocation data (derived from IP or device configuration);

Browser information, including browser type and language preference;

Reference and exit pages, including pages visited and other interactions with web content;

Details about the Products you purchase or obtain and how you use them;

Device event information, including crash reports, request and referral URL, and details of system activity (for example, if you encountered an error while playing our games or lost Internet access);

Other information (such as your image) that you may provide as part of your participation in live events; Y

We may also collect and store information locally on your device, using mechanisms such as cookies, browser web storage (including HTML 5), and application data caches. Examples of cookies we use include, but are not limited to: session cookies, preference cookies, security cookies.

## II. DATA USE

We use your personal information, both individually and in combination, in the following ways:

To operate our business and improve and personalize your experience, including to:

Operate, improve and develop the Site, the Game and other services;

Conduct research and analysis to develop and demonstrate our technology and better understand our players;

Complete online leaderboards and enable online matchmaking;

Facilitate the exchange on social networks;

Manage and offer contextual and targeted advertising;

Measure the effectiveness and distribution of advertising, including understanding who engages with our services and how they interact with our services;  
Detect security incidents, protect against malicious, deceptive, fraudulent or illegal activities and prosecute those responsible for that activity;  
Set up and maintain the accounts in which you register;  
Facilitate your game on multiple devices and / or platforms, if applicable;  
Identify, correct and fix errors or functionality problems;  
Facilitate competitions and contests;  
Other purposes for which you consent, when you provide personal information.  
To provide you with support, including: Facilitating surveys or questionnaires; and  
Communicate with you and respond to your specific requests or questions.  
To personalize our communications with you, including but not limited to: Providing you with service updates.

We retain the information we collect for as long as is necessary to provide our services, and we may retain that information beyond that period if necessary for legal, operational, or other legitimate reasons.

We may also de-identify, anonymize or aggregate the information we collect, or collect it in a way that does not directly identify you. We may use and share such information as necessary for our business purposes and as permitted by applicable law.

### III. HOW WE SHARE AND DISCLOSE YOUR INFORMATION

We do not share, sell or disclose your personal information to third parties (as these processing activities are defined in applicable privacy laws), except for:

-Service providers. We employ third parties located within and outside of your country of residence to collect or process personal information on our behalf for the purposes described above, including, but not limited to, conducting market research, facilitating live events, sending emails, or delivering and optimizing our services. We require any third party to use the data only on our behalf and for purposes consistent with this policy.

-Business colleagues. We may provide personal information to business partners with whom we jointly offer services. These partners include the companies that provide the platform on which you enjoy our Site, the Game and the Contracts, such as Ethereum, Binance, MetaMask or others.

-Affiliates. We may share personal information with our affiliated companies as necessary for the purposes described in this notice.

-Advertising partners. Through our services, we may allow third-party advertising partners to use tracking technologies and other tools to collect information about your use of our Services and your device (for example, your IP address, mobile identifiers, pages visited, location, browser) . information, time of day). We may also

combine and share such information and other information (such as your anonymous account information, demographic information, hardware specifications) with third-party advertising partners. These advertising partners may use this information (and similar information collected from other websites) for the purpose of serving you targeted advertisements when you visit third-party websites within their networks. This practice is commonly known as "interest-based advertising" or "online behavioral advertising." We may allow access to other data collected by the services to share information that may be useful, relevant, valuable or otherwise of interest to you.

-Disclosures to protect us or others. We may access, preserve and disclose any information that we store associated with you to outside parties if, in good faith, we believe that doing so is necessary or appropriate to: comply with law enforcement or national security requests and legal processes, such as a court order or subpoena; protect your rights, property or safety, ours or those of others; enforce our policies or contracts; collect amounts owed to us; or assist with an investigation or prosecution of actual or suspected illegal activity. In particular, if we receive a report that you have violated our policies, we may disclose that report and other relevant information to the platform on which our Game plays and the platform that facilitates the Contracts, such as Ethereum, Binance, MetalMask and others. .

-If RPS participates in a merger, acquisition, bankruptcy, dissolution, reorganization, sale of some or all of the assets or shares of the company, financing, public offering of securities, acquisition of all or part of our company, in a transaction or similar procedure, or in measures that contemplate such activities, some or all of the information could be shared or transferred to the corresponding third party and we will obtain your consent to do so if required by law or contract.

-Third-party add-ons. When third-party technologies or social tools are integrated into our services, those third parties may collect information about your use of our services.

Your consent to this Privacy Policy followed by your submission of such information represents your acceptance of that transfer.

The treatment of Customer Data and other Information will be carried out in a lawful, loyal and transparent manner with the user, in accordance with current regulations on data protection. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data will take place to an organization or country unless there are adequate controls in place, including security. of your data and other personal information.

#### IV. DATA SECURITY

This Website has implemented various measures to protect the security of your personal information, and to keep it confidential (unless it is of a non-confidential nature) and free from any unauthorized alteration. However, considering that no

security measure is 100% (one hundred percent) perfect, RPS does not guarantee information security at all times.

Where we have given you (or have chosen) a password to access certain parts of our website, you are responsible for keeping this password confidential. As the security of your information also depends on the precautions you take, we ask that you do not share your password with anyone.

Please note that all information that you disclose or content that you post in your user profile, comments, or other public parts of our website becomes public information. Because this information is publicly available, we cannot control how others treat it, so we ask all Users to be careful when deciding what information they choose to share.
